DECLARATION OF THE STUDENT

- 1. I do solemnly affirm that the statements and information furnished by me to the college are true to the best of my knowledge. I do agree that, if any information furnished therein is found to be untrue, I shall be liable for criminal prosecution as well as to forgo my admission.
- 2. I also undertake to pay the institute and hostel all dues regularly.
- 3. - 4. I also understand that the following will be deemed to be the acts of misconduct / indiscipline.

 - Involvement in any unlawful act.
